



## What's the process in getting approved for the state of Oklahoma?

1. Find your closest workforce location in your area by visiting the below link:

2. Contact your closest local workforce and **request eligibility screening for a WIOA Grant for training (WRITE DOWN YOUR ASSIGNED CASE WORKERS NAME & EMAIL AS YOU WILL NEED THAT FOR THE NEXT STEP)**
3. Click on the link below and complete it to its entirety. This link will create your Proposal & Acceptance letter that you need to provide to your Caseworker. **NOTE: Start Date needs to be at least 2 weeks from today's date**
