

What's the process in getting approved for the state of Oregon?

- 1. Find your closest workforce location in your area by visiting the below link: <u>Local Workforce Development Boards : About Us : State of Oregon</u>
- Contact your closest local workforce and request eligibility screening for a WIOA Grant for training (WRITE DOWN YOUR ASSIGNED CASE WORKERS NAME & EMAIL AS YOU WILL NEED THAT FOR THE NEXT STEP)
- 3. Click on the link below and complete it to its entirety. This link will create your Proposal & Acceptance letter that you need to provide to your Caseworker. NOTE: Start Date needs to be at least 2 weeks from today's date <u>https://codingclarified.com/proposal-and-acceptance-pdf-form/</u>

Title: Medical Insurance Coding Specialist/Coder.

Definition: A program that prepares individuals to perform specialized data entry, classification, and record-keeping procedures related to medical diagnostic, treatment, billing, and insurance documentation. Includes instruction in medical records and insurance software applications, basic anatomy and physiology, medical terminology, fundamentals of medical science and treatment procedures, data classification and coding, data entry skills, and regulations relating to Medicare and insurance documentation.

In order to be eligible to receive WIOA funds to train a WorkSource participant, the training provider and its program of study *must* be on the Eligible Training Provider List (ETPL).


